Judge Advocate's Notes

Section 218 of the Manual of Procedure

Sec. 218 - Officers and Chairmen, Duties and Obligations.

- (a) Officers.
- (1) Commander. Among the duties of a Post Commander, the Commander shall:
- a. Preside at all meetings of the Post, conducting such meetings in accordance with Article X of the Bylaws and Manual of Procedure and other applicable parliamentary rules.
- b. Enforce strict observance of the laws and usages of this organization, including Post, County Council (if applicable), District and Department Bylaws and the Congressional Charter, National Bylaws, Manual of Procedure and Ritual and all lawful orders from proper authorities.
- c. Insist that Post business and activities be conducted in such a manner that they do not violate any applicable governmental law, ordinance or regulation nor bring or tend to bring dishonor or embarrassment upon the Post, its members or the Veterans of Foreign Wars of the United States.
- d. Decide all questions of law and usage in the Post, subject to appeal pursuant to the Bylaws. e. Upon entering into office, appoint all other officers, committee chairmen and committees not otherwise provided for. The Commander may remove such appointed officers, committee chairmen and committees at their pleasure.
- f. Approve all disbursements of funds properly authorized by the Post by use of voucher or payment order. g. Assure that the office of Quartermaster is bonded according to Section 703 of the Bylaws.
- h. Assure that all dues and other monies due the National Headquarters and Department are forwarded promptly together with accurate reports and returns pertaining thereto. 74
- i. Assure that all reports are correctly prepared and promptly forwarded, that all the business of the Post is handled with dispatch and that all necessary licenses and permits are obtained for proper operation. Ensure that a properly completed Report of Election of Officers for the ensuing year is submitted to Department and National Headquarters by June 1.
- j. Assure that the Post Trustees have examined the books and records of the Post and prepared the Post Trustees Quarterly Report of Audit no later than the end of the month following the last day of each quarterly period.
- k. Assure that the Commander or their representative attend all properly called District Conventions or meetings and County Council meetings (if applicable). (see General Orders)
- l. Comply with and perform all of the duties required by the laws and usages of this organization, the provisions of these Bylaws, the Manual of Procedure and Ritual and Department, District, County Council (if applicable) or Post Bylaws pertaining to the duties and obligations of a Post Commander and lawful orders from proper authority and perform such other duties as are usually incident to the office.
- m. Be an ex-officio member of all committees.

Motions

Sec. 100117 of our National Bylaws and Manual of Procedures. Once a motion is made and passed by the membership it is in effect until the motion is rescinded by membership. To rescind a motion a member who voted for the motion will have to bring it before the membership. After this a 2/3 vote of membership is required to rescind the motion.

National Dashboard change

All Post and District leadership teams, to include Senior and Junior Vice Commanders, now have access to reports on the Dashboard through OMS. Please submit all program participation at this location. Vfw.org, on your main page under My VFW that is a training video for assistance.

Department Dashboard

All community service must be entered through vfwar.org. Your post should also be entering the VFW Auxiliary as well, be sure to pick the drop down and mark as Auxiliary. If you have not received training or need an account under members only, please contact the headquarters on Tuesday through Thursday.

Bonding

Don't forget, Employee Bonds are due by 31 September. The rate for these is \$8 per thousand. The application can be found on vfwar.org under resources, reports and forms.

Discipline of Members

We often forget that as members we have rights, but we also have standards to conduct ourselves by. The purpose of this corporation is fraternal, patriotic, historical, charitable, and educational: Often members need to be reminded of this. For this reason, our Bylaws and Manual of Procedures outline Discipline of Members in Sec 901. Section 902 governs Offenses, an offense that is so commonly abused is Sec 902, 6. Conduct prejudicial to good order and discipline or conduct unbecoming a member in their relations to the Veterans of Foreign Wars of the United Stated or other members. Please review these Sections and remind members at all levels.

Removal of Officers

Removal and Vacancies of Elected Officers or Committee Members: Section 220 Of our National By-Laws and Manual of Procedures outline how to remove an officer for one of the two following reasons:

- 1. Absent themselves from two (2) consecutive meetings or who has
- 2. Failure to fulfill the duties of officer specified in Section 218 of the Bylaws and Manual of Procedure.

Post Leadership

ATTENTION POST COMMANDERS

Your attention is directed to the requirement of timely filing of Internal Revenue Form 990 and 990-T, where applicable. All Posts with gross income under \$50,000.00 must file Form 990N (epostcard). You must now file your 990 online at IRS.Gov. FILING DEADLINE IS <u>NOVEMBER</u> <u>15th</u> FOR ALL POSTS IN THE DEPARTMENT OF ARKANSAS. Ref.: Section 501(C) 19 of the IRS Code. Be reminded that the Department Headquarters does not do this task for post and/or districts, However, if you are not sure what to do, we will try and guide you.

Post Commanders: Section 218(a)(1)k states: Post Commander will assure that he or his representative attend all properly called District Conventions or meetings (if applicable). **Note:** For those Posts not able to attend the District, they are asked to forward a report of their Post activities to the District Commanders prior to the District meeting to keep the District Commander informed of your activities also assist him in preparation for upcoming Council of Administration meetings. When you or your Rep attend the District meeting, they should be going back to the post meeting and sharing this information with all members. Please, we need your help in keeping the communications flowing at all levels. (please see Judge Adv, Notes in the Chronicles for full duties)

Post Commanders are urged to start planning suitable programs for the observance of Veterans Day (see Section 223 of the Manual of Procedures). Show your Post Pride by taking part in a Parade. Distribution of Buddy Poppies should be a part of your Veterans Day activities.
