## 2019-2020 Program Books and Directories

The Directories will be mailed out to the Post Commanders this month. Each Commander will receive 2 small Directories (1 for Commander and 1 for Post of each) the Directory will include, phone numbers for all officers, chairmen, post and Post officers, Auxiliary officers, Auxiliary Chairmen, District presidents and Department All State, recruiting, Post of the quarter, and District of the quarter. If you would like additional printed copies they can be purchased for \$10.00 through the Department Headquarters while supplies last. If any information is found to be incorrect, please contact the State Headquarters so that we can get the information corrected.

#### BONDING

Current Bonds for Post Quartermaster will expire August 31, 2019, and canteen mangers will expire September 30, 2019. All posts should remit the correct amount to Department Headquarters **<u>now</u>**. Amounts: Quartermaster \$3.50 per thousand minimum of \$2,000. Club manager and all others \$7.50 per thousand (which is a .50 cents increase) minimum of \$3,000. If you are bonding through an outside agency, please forward proof from company to VFW State Headquarters. Theses forms were mailed on July 31, 2019 to all Post and District Commanders. They can also be found on line at vfwar.org, resources under reports and forms.

Commanders are reminded that all persons handling post funds, including the Club Manager and Bingo Chairman, shall keep accurate and complete records. Post Trustees shall audit these records in the same manner as Post Quartermaster records.

# **POW/MIA Flag**

POW/MIA Flag – Official Display Days: Public Law 105-85 (November 16, 1997) indicates the days that federal agencies, military installations and U.S. post offices are required to display the POW/MIA flag. The days are: Veterans Day, Armed Forces Day, Memorial Day, Flag Day, and National POW/MIA Day.

# Legislative

For August, I have selected Health Care and Compensation and Benefits for membership to question their Congressmen and Senators on. When attending town hall meetings ask the congressional candidates what their stand is on these issues. Don't forget last month we covered Budget and Work Force Development and Accountability. Next month we'll be looking at Education, Employment and Transition Assistance and Defense/Homeland Security.

**Health Care:** To ensure that veterans receive timely access to high quality, comprehensive, and veteran-centric care at no added cost to veterans, Congress, VA and DOD must:

• Consolidate VA's community care programs into a single, integrated system.

- Modernize VA's health IT systems.
- Expand current caregiver benefits to veterans of all eras. 
  Strengthen VA and DOD health care and research for mental health and traumatic brain injuries (TBI).
- Further expand gender-specific programs and competencies. 

  Provide care and benefits to veterans and family members impacted by toxic exposures
- Prevent the increase of pharmaceutical copayments. 
  Conduct medical research on the benefits of medical cannabis.
- Extend telehealth services.
- Make nursing home eligibility part of the VA health care benefits package.

**Compensation and Benefits**: To ensure veterans and their dependents have timely access to earned benefits, Congress and VA must:

- Require treatment of presumptive conditions as a claim for disability compensation.
- Establish presumptive service connection for hearing loss, tinnitus, TBI, and exposure to certain toxic substances.
- Increase burial allowances to account for inflation and include spouses' information on all headstones.
- Reform the Gulf War Illness Disability Benefits Questionnaire.
- Address veterans' homelessness by increasing the availability of affordable housing. 
  Adjust Grant and Per Diem Program rates for inflation.
- Prohibit VA compensation and non-service-connected pension from being considered countable income for homeless programs.

#### **Control of Units**

Section 709 – Control of Units, National By-laws paragraph 6. In addition to other legal requirements under existing local laws or Department By-Laws, no Post, County Council, District, or any holding company or corporation subordinate thereto, shall purchase, sell or otherwise transfer title or any interest in any real estate unless written notice of such proposal has first been given to each member of said unit ten (10) days prior to such regular or special meeting at which the proposal is to be considered and then only by two-thirds (2/3) vote of approval of those members present and voting at such regular or special meeting. In addition, at least thirty (30) days prior to such meeting notice shall be provided to the Department Commander who shall review any sale, purchase, transfer or encumbrance to determine whether such transaction serves the purposes of the Veterans of Foreign Wars of the United States as prescribed in the Congressional Charter. Failure to comply with these provisions shall nullify said transactions.

### **POST COMMANDERS** Notify IRS of Quartermaster Change

In January 2014, the Internal Revenue Service (IRS) began requiring entities with and EIN to file IRD Form 8822-B to report the latest change of address or responsible party. Form 8822-B must be files within 60 days of the change. The purpose of Form 8822-B is to notify the IRS of you changes your business mailing address, your business location or the identity of your responsible party. ### 2019 Annual Report for Nonprofit Corporation PAST DUE

**Deadline:** August 1, 2019: Just received information from the Secretary of the State office that Posts were waiting for the postcard mail out regarding Annual Nonprofit renewals. It is all on line now. Please go to <u>www.sos.arkansas.gov/BCS</u> to file your 2019 report of officers. There is no penalty for being late, but it could hurt the post in the future. # **REMOVAL OF AN OFFICER**

Section 220 of the National By-Laws, "Vacancies and Removal of Elective Officers" states that "Any elective Post Officer removed by the Department Commander, by reason of failure to pay current dues or by vote of the Post under the provisions of this section, shall not be eligible to serve in any Post office in the same administrative year in which the Officer is removed."
