Please look over your unpaid, expired and the needy in nursing homes. Each and every one of us need to do our part. Together, let's make this Department a great success.

Deadline for All-State is June 30, 2019. However, the deadline to receive hats at the state convention has passed. If you receive All-State recognition, you can still purchase your hats at the Post and District level through the Department Headquarters. If you obtain 100% in membership please contact the Department Headquarters to obtain the form needed to complete, or find it on our web site <u>www.vfwar.org</u> and submit. Good luck and let us take our Department to the next level.

#### COVID-19

#### The below information was put our by our National Headquarters in executive order #2 dated 24 April 2020.

**Districts:** Districts that are able to conduct Conventions in accordance with Section 403 of the National By-laws no later than June 14, 2020 are encouraged to do so; otherwise, those Districts are to elect officers at their next regular or special meeting.

Alternatively, if on July 24, 2020 no business can be transacted at a District Convention and no elections held, the 2019-20 terms of all District officers are ended thereby vacating those offices. The incumbents having satisfactorily served to the end of the term as defined in Section 719 of the National By-laws. Those positions for which succession is provided will be immediately filled pursuant to Section 420 of the National By-laws and Manual of Procedure (the Senior-Vice Commander will succeed to Commander and Junior-Vice will succeed the Senior-Vice respectively). Immediately thereafter, the District Commander shall appoint a Quartermaster Pro Tempore (as well as all other appointments pursuant to District and National By-laws); all other elected vacancies shall be filled at the next regular or special meeting.

If on a date no later than June 14, 2020 a District Convention cannot be held, a pro-forma District Convention shall be conducted for the purposes of maintaining compliance with Section 403 of the National By-laws; no business shall be transacted due to lack of a quorum as "the inability to transact business does not detract from the fact the society's rules requiring the meeting to be held were complied with and the meeting was convened-even though it had to adjourn immediately" pursuant to Robert's Rules of Order Newly Revised.

Posts: Posts that are able to conduct meetings for the purpose of electing officers are encouraged to do so.

Alternatively, if on July 24, 2020 no election can be conducted, the 2019-20 terms of all Post officers are ended thereby vacating those offices the incumbents having satisfactorily served to the end of the term as defined in Section 719 of the National By-laws. Those positions for which succession is provided will be immediately filled pursuant to Section 220 of the National By-laws and Manual of Procedure. Immediately thereafter, the Post Commander shall appoint a Quartermaster Pro Tempore (as well as all other appointments pursuant to Post and National By-laws); all other elected vacancies shall be filled at the next regular or special meeting.

Nothing within this section shall prevent a Post from deciding to have any elected and/or appointed officer serve consecutive terms in the same position so long as their subsequent election and/or appointment is done so in accordance with Section 220 of the National By-laws and Manual of Procedure

#### **Community Service**

Commander has selected the Outstanding Community Service Post, the post will be announced at the State Convention.

#### **National Home**

Department Junior-Vice Mark Davis is not going to the National Home this year, however, if your post has any donations or items to go, please get them to him TODAY and he will assure that they get to the home.

#### **State Convention**

This year the State Convention will be June 13, 2020, at the Department Headquarters at 11:00 am. Their will be a Council meeting at 10:00 am prior to. ALL Council members plan on attending and the Department will supply lunch while supplies last.

#### ATTENTION

DISTRICT COMMANDERS / COUNCIL MEMBERS: If you are a brand new elected council member, BE SURE TO HAVE PROOF OF ELEGIBILTY ON HAND at the State Convention. This proof will be handed over to the Department Adjutant and kept on file before you are sworn in.

#### Awards

Commander Beams has chosen to announce some of the awards at the State Convention, however the awards will be presented at an Awards event established when restrictions are lifted to have a celebration.

#### 120<sup>th</sup> National Convention

The National Convention in Reno has been cancelled, if you made reservations through the VFW you should have got a cancelation confirmation by email. If you booked space outside the block you will have to contact that hotel for yourself.

#### **Memorial Day**

#### There will be no official state ceremony this year due to COVID-19.

Section 223 of the National By-laws and Manual of Procedures provides that each Post shall make the necessary arrangements for proper observation of Memorial Day. Officers should see that suitable grave markers, wreaths and United Stated Flags are placed on the graves of deceased veterans.

#### Installation

*Installing Officers:* Installing officers will see that the provisions of Section 216 of the National By-Laws and the Manual of Procedure are properly carried out and that all officers are members in good standing and qualified to hold office prior to installing Post officers for the current year. Post officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Post-Election Reports must be submitted following Post election of officers in April and no later than June 1 to the National Headquarters. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post-Election Reports received electronically will be forwarded to the Department Headquarters.

#### Posts

**Post Commanders**: Delegate strength will be based on membership on May 15, 2019. Delegates to the Department Convention shall be elected at a regular meeting of the Post held not less than thirty (30) days prior to the Convention. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post.

**Post Commander**: PRIOR TO ELECTIONS: VERIFY THAT ALL RUNNING FOR OFFICE ARE PAID MEMBERS. Over the Past several weeks the Department Commander has obtained correspondence from National that individuals that have been elected, are unpaid. If any elected officers are annual

members we highly encourage that each quartermaster collect their dues now and pay them so no elected officers will be removed from offices during the 2019-2020 year.

**ATTENTION** is directed to Section 222 of the National By-Laws This portion of the By-laws states that each post will register one delegate to the National Convention. This is being waived this year. **DO NOT** send any registrations to National.

For those Post who do not have computers to please forward your election report form to This office (State Adjutant Office) who will file the report for you. Please ensure that all elected and appointed Officers are listed with correct phone # and addresses on your election report, this will facilitate preparation of the Department directory and USPS listing for mailing of General Orders.

## Districts

*District/Post Commanders:* Proof of Eligibility Requirements for Officers: All Posts, Districts and Departments should be reminded of the provisions of Sections 216, 416, and 516 of the Manual of Procedure that officers, elected and appointed, shall not be installed or assume the duties of their office until proof of eligibility has been submitted to the respective Adjutant and properly reviewed.

## All District Commanders are asked to make sure that the District election report is completed with all of the elected and appointed Officers completed and forward to the State Adjutant immediately after the District Convention. This will facilitate the preparation of the Department Directory.

*District Meeting Dates for 2020-2021* All newly elected District Commanders are reminded please try within 30 days to submit to the Department Adjutant a list of all meetings for the 2020-2021 year (if you have them). This will help us for planning purposes.

Per Section 403 of the National By-laws, each District should hold two (2) regular meeting for the purpose of transacting business and conducting a school of instruction and each District shall hold an annual District Convention for electing District officers. You can still hold one every quarter if your district desires that.
