Buddy Poppy Display Contest – Artistic or Decorative Use of Poppies (Post Home displays, table centerpieces, corsages, pictures, plaques, models, scenes, hats, novelty pieces, etc.)

CATEGORY 2. Memorial or Inspirational Displays (Wreaths, memorial tablets or plaques, patriotic or devotional themes) (a) Displays must be designed to honor the dead, to inspire devotion to God and Country, or to dramatize the activities supported by the Buddy Poppy. (b) At least one (1) of the poppies used in the display must be in its original form and color, with label attached.

The ceremony will be held at 10 a.m., Monday, November 11, 2019 in MacArthur Park in front of the MacArthur Museum of Arkansas Military History, 503 East 9th Street, Little Rock, AR 72202.

In case of inclement weather, the ceremony will be held at the Arkansas Arts Center in the Atrium. The Arkansas Arts Center is on the corner of East 9th and Commerce Streets in MacArthur Park.

Following the ceremony, from 10:30 a.m. to 1 p.m., a Veterans Eligibility Fair will be held in the MacArthur Museum of Arkansas Military History. AETN will be filming some 9/11 digital shorts of service members in attendance.

Service Officer

Be sure that when you wish to file a claim regarding Agent Orange, be sure to file for the presumptive illness caused by the dioxin exposure. Agent Orange is not an illness it is a cause. There are at this time 14 illnesses presumed related to exposure there is more in process to hopefully be added, we are in waiting for this decision to conclude.

The process for HR 299 is still on stay at this time. Procopio claims have been included in this stay, we don't think this is right, but is what it is. Bureaucracy. I can understand the reasoning behind the stay, although it has been spoken to for many years one would think a plan would have been in place to correctly process these claims. Be sure if you are going to file a claim be sure to include as much of deck logs you can showing the vessels location. The more we can do to provide the locations the faster and more accurate the decisions can be made. We don't wish to have overpayments and anger when it has to be paid back, it would be unnecessary stress, more than the stress to find the deck logs.

Newly returning Veterans, I know it is easier to file claims on your own. Please speak with a service officer of your choice that has some experience with the bureaucracy and what works best, please don't reinvent the wheel and delay claims due to not having all the information. To be forewarned is to be forearmed.

Membership

All Members: Members are reminded that under the new subscription dues plan, an annual member due expire on their anniversary month. Annual members are encouraged to renew their dues prior to their anniversary date to avoid a lapse in continuous membership. Officers and committee members, whose membership is not in

good standing by reason to pay current dues by their anniversary date, shall forfeit eligibility to hold any office the remainder of the administrative year. In addition, every effort should be made to renew the membership of continuous members and sign up new and recover former members at all times during the year

Post Commanders and District Commanders and inspecting officers

Your attention is directed to section 703 of the National By-Laws – Bonds. Each Accountable Officer of this organization shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which he may be accountable. Liquid assets are defined as cash on hand or in the bank and other negotiable instruments readily convertible into cash.

Post Commanders

Use of Seals, Emblems, Badges, Insignia and Uniforms: Sec. 803 - Manufacture and Use of Seals, Emblems, Badges, Insignia and Uniforms. The seals, uniforms, emblems, badges and insignia of the Veterans of Foreign Wars of the United States, or goods bearing same, shall be manufactured only on order of or with the express written consent of the Quartermaster General of the Veterans of Foreign Wars of the United States. Such written consent shall be the sole discretion of the Quartermaster General of the Veterans of Foreign Wars of the United States unless otherwise directed by the Commander-in-Chief, the National Council of Administration, or National Convention. No subordinate unit, member or person shall engage, by contract or otherwise, for the manufacture of such seals, uniforms, badges, emblems or insignia, or goods bearing same, unless such written consent has been obtained. No person shall be entitled to use or wear any seal, emblem, badge, insignia, or uniform of the Veterans of Foreign Wars of the United States unless a member in good standing or unless such written consent has been obtained. No member or other person shall use or wear any seal, emblem, badge, insignia or uniform of the Veterans of Foreign Wars of the United States while engaged in any commercial or political activity in such a manner as likely to falsely convey that such activity is approved or endorsed by the Veterans of Foreign Wars of the United States. The design of seals, uniforms, emblems, badges and insignia and goods and services using such seals, uniforms, badges, emblems or insignia shall be as provided in the Manual of Procedure. Ownership of all seals, badges, emblems and insignia shall remain vested in the Veterans of Foreign Wars of the United States and the right to use or wear such seals, badges, emblems, insignia or uniforms shall be a license only which shall be automatically revoked when such person ceases to be a member or authorization is revoked.

Podiums: All officers should obtain current 2019 copies of the podium edition of the Congressional Charter, By-Laws, Manual of Procedure and Ritual. Copies of the revised edition of the Congressional Charter, By-Laws, Manual of Procedure and Ritual are available through the VFW Store at National Headquarters! The 2019 revised edition reflects the amendments adopted by the 120th National Convention, which became effective on August 25, 2019.

Membership: Is directed to section 103, Manual of Procedure, which prescribes the manner in which applications for membership will be handled. Applications for membership of new, reinstating or transfer members must be voted on by the members present at a regular Post meeting. No Post, County Council, District, Department or National officer, or any other member, has authority to reject the application card of a person who is eligible for membership.
