#### MEMBERSHIP

MEMBERSHIP: Veterans of Foreign Wars National By-Laws provide for only one type of membership; that is active membership in the Veterans of Foreign Wars. There are no provisions in the National ByLaws for national membership cards, associate member cards, honorary membership cards, courtesy membership cards or conducting club operations open to the public. This activity endangers the VFW standing with the Internal Revenue Service as a nonprofit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW By-Laws or procedure.

### **COMMANDERS AT ALL LEVELS**

#### AUDITS

At Post and District levels we are forgetting the importance of reporting, Audits are to be turned into Department by the following dates July 31, 2019, October 31, 2019, January 31, 2020 April 30, 2020. As of August 29, 2019, there are 37 Post and 4 Districts that have not submitted audit reports. Post Quartermaster Bonds are now past due. Over 20 Post in the Department have not shown proof of bonding to the Department, please forward any information as soon as you can.

Though these have probably been completed, the following Post have not submitted the Report of Audit that was due by July 31<sup>st</sup>. Post that have not transmitted the report to the Adjutant by 14 September will be placed on suspension pending receipt at headquarters.

### **Post ByLaws**

**POST BYLAWS**: Every Post operating any type of activity, particularly a canteen, should adopt Post By-Laws. Unfortunately, a relatively small number of Posts have done so. Few have complied with Section 202 of the National By-Laws and Manual of Procedure which requires that such By-Laws be submitted to the State Commander and Commander-in-Chief for review. By-Laws will save many hours of argument and remove causes for misunderstanding and dissension.

Remember that all actions of a Post shall be subject to ratification by vote of its members at a regular post meeting.

# **Removal of Officers**

Removal and Vacancies of Elected Officers or Committee Members: Section 220 Of our National ByLaws and Manual of Procedures outline how to remove an officer for one of the two following reasons:

- 1. Absent themselves from two (2) consecutive meetings or who has
- 2. Failure to fulfill the duties of officer specified in Section 218 of the Bylaws and Manual of Procedure.

# **Discipline of Members**

Please review these Sections and remind members at all levels.

adjudicated by old classification coding. I find that all claims are on stay until 1-1-2020 but get in the pile by having the record of re-open. Don't count on VA to pull all old claims and add to their stack. If Spouses were not able to File because of a denial be sure to have them file for DIC and any accrued benefits.

Be sure to join any registry's (Burn Pit, Agent Orange) Go to VA.gov and check for one that fits your situation.
